<p>10. Public expenditure on education as a percentage of total public expenditure: (i) increased public expenditure on education, as compared with a base year value, or (ii) maintained public expenditure on education at 20% or above.</p> <p>At country-level, total public education expenditure is computed as the sum of (i) expenditure on education by all ministries, (ii) expenditure on education by local government, (iii) employer's contribution to non-salary social benefits (if not charged directly to the education ministry's budget). Next, the share of education spending in total government spending is calculated by dividing total public education expenditure over total public expenditure (excluding debt service), and multiplying by 100.</p> <p><i>Interpretation:</i> This indicator reflects countries' financial commitment to education. Equitable allocation of teachers, as measured by the relationship (R2) between the number of teachers and the number of pupils per school: The R2 is the statistical relationship between the number of pupils and the number of teachers per primary school.</p> <p><i>Interpretation:</i> The closer to 1 is the value of the R2 (which ranges between 0 and 1), the greater the relationship between the number of students and the number of teachers at the school level. Repetition and drop out impact on efficiency, as measured by the internal efficiency coefficient (IEC) at the primary level: The ratio between the theoretical number of pupil-years required to produce a number of graduates from a given school-cohort for primary (in the absence of repetition or dropout) and the actual number of pupil-years spent to produce the same number of graduates, where a pupil-year is defined as one year spent by one student in one grade (regardless of whether the pupil is a repeater or will later drop out of the system)</p> <p><i>Interpretation:</i> The IEC ranges from 0 (no students complete a full cycle at the relevant level) to 1 (all students who initially enroll graduate without any repetition or dropout – i.e. perfectly efficient system). Sector pooled funding refers to a diverse group of grant or credit modalities with varying instruments and mechanisms to support implementation of an endorsed national education sector plan.</p> <p><i>Interpretation:</i> Harmonized funding (co-financed or sector-pooled) is typically recommended to create a space for dialogue and coordination amongst funding partners.
