



A. IMPLEMENTATION PROGRESS RATINGS

Ratings: Current Reporting Period












Progress/Change in Ratings












% of 59 grants (in each rating group)

B. DISBURSEMENT VS UTILIZATION



A cumulative amount of US\$ 399 million was disbursed of which GAs reported that US\$ 188 million were utilized out of a total of US\$400 million approved (for 59 out of 66 COVID-19 accelerated grants.)

C. SUMMARY OF PROGRESS

- 59 out of 66 grants have at least one progress survey submitted by the respective Grant Agent and reviewed by the Secretariat for reporting progress made during the reporting period against outcomes and outputs planned.
- -Grouping current implementation progress ratings show that 56 grants report their most progress rating as Moderately Satisfactory or above, and only 3 grants Moderately Unsatisfactory or below.
- -Some summary results are that 95% (56 of 59) of grants include distance/ home-based learning programs to support children during COVID-19. Similarly, 69% (41 of 59) of grants include distance/ home-based teaching programs to support teachers during COVID-19.



1. MITIGATION AND RESPONSE

 A cumulative 40.41 million out of a total of 100.36 million children targeted have been reached. (n= 52 grants w/ data available)



 A cumulative 15.72 million out of a total of 38.87 million girls targeted have been reached. (n= 46 grants w/ data available)

Teachers supported with distance/ homebased teaching programs



 A cumulative 0.17 million out of a total of 1.18 million teachers targeted have been reached. (n= 40 grants w/ data available)



 A cumulative 0.06 million out of a total of 0.21 million women teachers targeted have been reached.


